I/We hereby apply for the Issuer's ATM Card. I/We declare that the information provided in this application form is true and correct and shall inform Issuer of any changes thereto. I/We hereby authorize Issuer to verify any information provided herein from whatever source(s) it may consider appropriate.

I/We further agree to be bound by the following terms and conditions:

- 1. I/We undertake that this application form, signed by me/us is for the issuance of an Issuer Limited ATM Card for myself/ourselves and for my/our use and that in doing so, I/We do not represent the interest of someone else.
- 2. I/We understand that Issuer may decline my/our application without any reason given me/us.
- 3. I/We understand that the Issuer ATM Card remains the property of Issuer and I/We will surrender it unconditionally and without reservation upon demand by Issuer.
- 4. I/We undertake not to use or attempt to use the ATM Card without sufficient funds in my/our account to cover the ATM withdra wal or purchase transactions.
- 5. I/We undertake not to use or attempt to use the ATM Card after the Bank has notified me/us of its cancellation or withdrawal.
- 6. I/We undertake to immediately inform Issuer, when the ATM Card is lost, stolen or misplaced, giving details of the loss, theft or misplacement. I/We understand that if I/We fail to so inform Issuer, I/We may increase the chances of the occurrence of fraud on my/our account, and Issuer would not be responsible in anyway whatsoever for any unauthorized transaction(s) on my/our account during this period.
- 7. I/We understand that I am/we are liable for any transaction(s) that occur(s) on my/our account prior to reporting the loss of my/our Issuer ATM Card to Issuer.

- 9. Under no circumstances will I/we disclose my/our Personal Identification Number (PIN) to anybody, including family members, business colleagues and Issuer staff, and Issuer will not accept any liability should I/we disclose my/our PIN to another person.
- 10. I/We recognize that I am/we are not allowed to give my/our ATM card to anyone except those involved in any Point of Sale transaction. The ATM card is owned by Issuer and has been given to me/us in trust and is therefore not transferrable.

I/We hereby authorize Issuer to debit my/our account directly with all transactions undertaken at the Point of Sale Terminals or ATMs with my/our ATM card and I/we take full responsibility for these transactions. I/We also agree to accept Issuer's receipt PF withdrawals and transactions as conclusive and binding.
